Terms and Conditions

1. Information on how to enter and the prize forms part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. Entry is open to NSW residents who purchase a new, demonstrator or used vehicle from the Promoter between **8 March 2010 and 11:59pm EDST on 30 April 2010 ("Promotional Period")**. Business purchasers; federal, state and local government purchasers; fleet purchasers including registered national fleet purchasers; dealers to whom vehicles are wholesaled; and Employees (and their immediate families) of the Promoter and agencies associated with this promotion are ineligible to enter.
